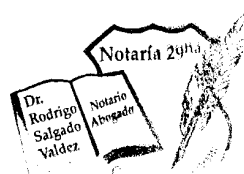

1. **Frank's International Americas B.V.**, a private limited liability company organized and existing under the laws of the Netherlands, with Ministry of Justice number BV 1381232, having its corporate seat in Amsterdam, The Netherlands with address Prins Bernhardplein 200, 1097 JB Amsterdam, The Netherlands, registered at the Trade Register under number 34250711 (the "Company"), has been incorporated by notarial deed (the "Incorporation Deed"), executed before Tjien Hauw Liem, civil law notary, officiating in Amsterdam on June 22, 2006, in relation to which the statement of no objection has been granted by the Ministry of Justice on June 21, 2006, under B.V. number 1381232.
2. The Company is registered with the Trade Register of the Chamber of Commerce for Amsterdam, The Netherlands under file number 34250711.
3. The Company is legally existing under the laws of the Netherlands, and has as such the corporate power to own assets and enter into obligations in its own name and to transact any business within the objects clause as set forth in article 3 of the articles of association of the Company.
4. Since the Company has not been dissolved, is not in liquidation, has not merged nor demerged as a result of which the Company ceased to exist, has not been declared bankrupt and has not been granted suspension of payments, it may be considered in good standing (an expression, however, which has no recognized meaning under Netherlands law).
5. The managing directors of the Company are:
  1. **Frank's International, Inc.**, a company organized and existing under the laws of the State of Texas, United States of America, having its corporate seat in Houston, Texas, United States of America, with address in 10260 Westheimer Road, Suite 700, Houston, TX 77042, United States of America, registered with the Office of the Secretary of State, Corporations section in Austin, Texas, United States of America, under number 103782900 (managing director A); and

2. **Intertrust (Netherlands) B.V.**, a private ~~limited liability~~ company organized and existing under the laws of the Netherlands, having its corporate seat in Amsterdam, The Netherlands, with address Prins Bernardplein 200, 1097 JB Amsterdam, The Netherlands registered with the trade register under number 33144202 (managing director B).

In accordance with article 19 paragraph 1 of the articles of association of the Company, the board of managing directors has the authority to represent the company and such authority is also vested in a managing director A and a managing directors B acting jointly.

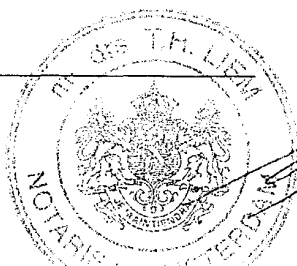
The abovementioned statement does explicitly not contain any judgement as to the authority of any of the managing directors of the Company to represent the Company, in case of any conflict of interest.

The above statements are solely based on:

- a. the original extract of the Trade Register of the Chamber of Commerce for Amsterdam, The Netherlands of the registration of the Company, dated April 11, 2011 (the "Extract"), which has been attached to this certificate together with a copy of the translation thereof in English and confirmation by telephone to me by said Chamber of Commerce at the date hereof that the Company's registration has remained unaltered since April 11, 2011; and
- b. a copy of the Incorporation Deed.

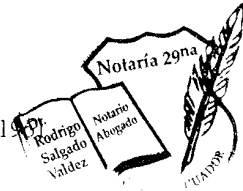
Furthermore, I have assumed that the general meeting of shareholders of the Company has not adopted a voluntary winding-up resolution and that no petition has been presented, nor an order made by a court, for the bankruptcy, dissolution or moratorium of payments, that no receiver, trustee, administrator or a similar officer has been appointed in respect of the Company and that no deed of merger or demerger as a result of which the Company would cease to exist has been executed. Although not constituting conclusive evidence thereof, my aforementioned assumption is supported by (i) the contents of the Extract, and (ii) information obtained by telephone today from the Bankruptcy registrar of the Court of Amsterdam, The Netherlands with respect to the Company.

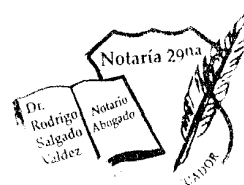

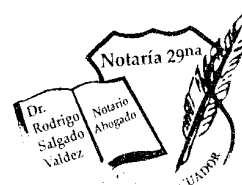
