Este poder subsistirá hasta ser expresamente revocado y se lo otorga para los efectos determinados en el Artículo 6 de la Ley de Compañías del Ecuador.

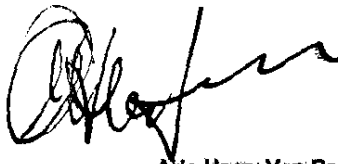
POWER OF ATTORNEY

In my capacity of authorized officer of BRENNTAG (HOLDING) B.V., a company incorporated and existing under the laws of The Netherlands I hereby appoint Mr Gustavo Vallarino Marcos as proxy and judicial representative for such company in the Republic of Ecuador. By virtue of this power of attorney, on behalf of the principal, the agent is entitled to execute all obligations legitimately acquired by the principal and that must be fulfilled in Ecuador, as well as respond and file complaints before the Ecuadorian courts and judicial or arbitration tribunals, and appear on behalf of the principal in proceedings, hearings and other actions ordered in such procedures, and to file administrative claims in Ecuadorian public agencies and in general appear on behalf of the principal before such entities. This power of attorney will subsist until expressly revoked and it is granted for the effects determined in Article 6 of the Ecuadorian Companies Act.

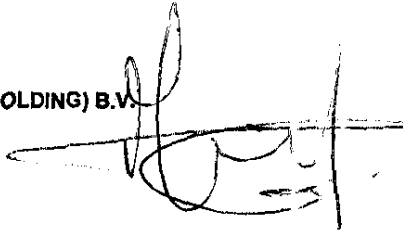
