



SPECIAL POWER OF ATTORNEY

INVESTMENTS PACIFIC, LLC, a company incorporated under the laws of the State of Delaware, United States of America, with registration number 4970206, whose registered office is at 160 Greentree Drive, Suite 101, Dover, Delaware 19904, United States of America, hereinafter the "Principal" hereby grants a **SPECIAL POWER OF ATTORNEY** in favor of **JUAN MARIO JALIL PERNA**, male, of age, married, a citizen of Ecuador, bearer of the personal identity card number 091362841-8, with legal domicile in Guayaquil, Ecuador, hereinafter the "Attorney", by means of which the Attorney, acting **individually** on behalf of the Principal shall have the authority to **individually** execute and perform this Special Power of Attorney on the Company's behalf in Ecuador or in any part of the world, for the following: **One:** To receive the Principal's correspondence, mail and notices; to issue, sign and deliver on the Principal's behalf any document, application or writ in which the Principal is a party thereto, including Public Registries and Public Notaries; **Two:** To participate in any General Assembly or Shareholders' Meetings in which the Principal is a shareholder or a member of; and **Three:** To participate or intervener in the acquisition of shares or membership interests of other corporations or companies.

The Special Power of Attorney that is hereby granted shall be limited to the authorities described herein above.

For the purposes of the Special Power of Attorney that is granted by means of this instrument and within the limitations set forth therein, the Attorney, acting individually, is duly authorized to execute and deliver, under the terms and conditions that are considered convenient for the Principal, any and all other private or public documents that may be necessary or proper to give effect and consummate the transactions contemplated thereby and the Attorney is further empowered to execute and/or sign any other acts or contracts that are necessary to consummate the authorities granted to said Attorney.

The Attorney may substitute or delegate, totally or partially the present Power of Attorney, as well as to revoke or accept the resignation, at any time, of any of the persons in which such Power of Attorney has been delegated or substituted in. It shall be understood that any such delegation, substitution or their eventual revocation or resignation shall not invalidate the present Power of Attorney, provided that such Power of Attorney is not expressly revoked by the Principal or the attorney-in-fact resigns his mandate.


