





### POWER OF ATTORNEY

Atlas Trading & Shipping Limited, a company incorporated in the Islands of Bernada on 25 May 2005 having its registered office at Canon's Court, 22 Victoria Street Hamilton HM 12, Bernada (hereinafter called the "Company") HEREBY CONSTITUTES, APPOINTS AND NOMINATES Claude Justamond Mayorga (the "Attorney") to be its true and lawful Attorney in its name and on its behalf as follows:

- 1. The company is a shareholder of Atlas Trading & Shipping del Ecuador (ATLASHIP) S.A. of the Republic of Ecuador; and, pursuant to Article 1 of the Law to Amend the Companies' Law of Ecuador, published in the Official Gazette of Ecuador #591 of Friday 15<sup>th</sup> of May, 2009 hereby grant Special Power of Attorney as ample and sufficient as required by the laws of the Republic of Ecuador, on behalf of Claude Justamond Mayorga so that he represents the Company for the purposes foreseen under the referred Art. 1.
- 2. It is hereby expressly set forth that this power of attorney does not authorize the Attorney to attend the General Shareholders' meetings of the company Atlas Trading & Shipping del Ecuador (ATLASHIP) S.A. unless a special power is granted to that effect; and, that in compliance with the above-mentioned legal provision, the Attorney shall for no reason be liable for the obligations of the above mentioned foreign company, nor shall he be enabled to register in the Taxpayers Register of Ecuador, nor to file Income Tax Returns.

I hereby set on record that Atlas Trading & Shipping Ltd. does not exercise any other corporate activities in Ecuador, regularly or occasionally; thus, it shall not be considered a permanent establishment in the country, nor shall it be obliged to be established in Ecuador, because it simply has an investment in Atlas Trading & Shipping del Ecuador (ATLASHIP) S.A.

AND it further declares that all and every of the acts, deeds and things done by its Attorney for the aforesaid purposes shall be good, valid, binding and effectual as if the same had been signed, sealed and delivered, given, made or done by it and it undertakes at all times hereafter to ratify and confirm whatsoever its Attorney shall lawfully do or cause to be done by virtue of this POWER OF ATTORNEY.

This Power of Attorney shall be valid for a period of twelve (12) months from the date hereof.


