Resolution of the Partnership

Granting a Limited Power of Attorney

22nd March 2011

The undersigned, being the duly authorised signatories of the general partner of the Charybdis Limited Partnership, do hereby adopt the following resolution:-

Whereas:

- (a) The Charybdis Limited Partnership ("the Partnership") is a New Zealand Limited Partnership created and registered under the provisions of the Limited Partnerships Act 2008 ("the Act"), with its registered office at Level 3, 280 Parnell Road, Parnell, Auckland, New Zealand.
- (b) By virtue of section 47 of the Act, General Partner Limited, as general partner of the Partnership, is fully empowered to exercise signatory authority on behalf of the Partnership.
- (c) The Partnership wishes to grant a limited power of attorney to Franberc Andrade Ceballos ("the Attorney"), an Ecuadorian national resident in Guayaguil, and holder of Ecuadorian National Identity Card Number 091251331-4, for the purposes of acquiring certain shares on behalf of the Partnership.

It is hereby resolved that:

- 1. The Partnership grants to the Attorney a limited power to act as its attorney-in-fact for the following purposes:
 - (i) To purchase shares in Reilet S.A., Servicios Integrales de Exportación Agrícola C.A., Nutriorganic S.A., Nutriecopad S.A., and Vitanutriorganic S.A. (collectively, "the Shares"), on behalf of the Partnership.
 - (ii) To execute any and all documents and perform all such acts as are required under the laws of Ecuador in order to fully effect transfer of the beneficial and legal title to the CERTIFICOL ES CONTRACTA Shares to the Partnership. AL DOCUMENTO GUE


