POWER OF ATTORNEY**

KNOW ALL MEN BY THESE PRESENT that **WDC Limited Partnership** a Bermuda exempted limited partnership having its registered office at Milner House, 18 Parliament Street, Hamilton HM 12 Bermuda formed and existing under the laws of Bermuda (the "Partnership") does hereby make, constitute and appoint, Rodrigo Cesar Alvarez Tobar with number of identity card Ecuadorian 171101187-2 , (the "Representative") to be its true and lawful attorney-in-fact for it, in its name and on its behalf to do all or any of the following acts, matters and things namely:

1. to do all such acts and things and to execute all documents, agreements, certificates or instruments necessary or advisable under applicable Ecuadorian legislation to incorporate, on behalf of the Partnership, a company: MUNDOTEC S.A. Mundo Tecnológico de Soluciones Inalámbricas, such company to be constituted and domiciled in Ecuador (the "Subsidiary");
2. to appear on behalf of the Partnership, at meetings of the shareholders or stockholders of the Subsidiary and to exercise all votes and rights capable of being exercised by the Partnership in respect of the shares, stock and other securities of the Subsidiary held by the Partnership.

The Partnership hereby gives and grants to the Representative or his or her substitute or substitutes full power and authority in the premises hereby ratifying, allowing and confirming, and agreeing to ratify, allow and confirm, whatsoever shall lawfully be done in the premises by virtue hereof.

This Power of Attorney shall be conclusive and binding upon the Partnership and no person or corporation having dealings with the Representative or his or her substitute or substitutes under this Power of Attorney shall be under any obligation to make any inquiries as to whether or not this Power of Attorney has been revoked and all acts hereunder shall be valid and binding on the Partnership until express notice of its revocation be received by such person or corporation.

The Company irrevocably and unconditionally undertakes to indemnify the Representative and his or her respective substitute or substitutes and their respective estates against all actions, proceedings, claims, costs, expenses and liabilities of every description arising from the exercise, or the purported exercise, in good faith of any of the powers conferred by this Power of Attorney.

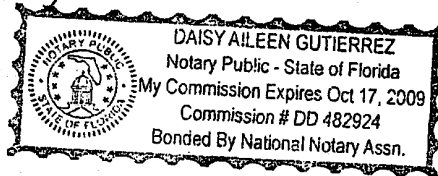
