Abstract *Background:* The purpose of this study was to determine the prevalence of self-reported depression and anxiety among a sample of young adults in the United States. *Methods:* Data were obtained from the National Longitudinal Study of Adolescent Health (Add Health), a nationally representative sample of adolescents in grades 7–12. The study included 15,197 adolescents who completed a self-report questionnaire in 1994–1995. The questionnaire included questions about depression and anxiety. *Results:* The prevalence of self-reported depression was 11.1% and the prevalence of self-reported anxiety was 10.1%. The prevalence of both depression and anxiety was 6.1%. The prevalence of depression and anxiety was higher among females than males. The prevalence of depression and anxiety was higher among adolescents who were in the lowest socioeconomic status (SES) group than those in the highest SES group. *Conclusions:* The prevalence of self-reported depression and anxiety among young adults in the United States is high. The prevalence of depression and anxiety is higher among females than males and higher among adolescents in the lowest SES group than those in the highest SES group.
