Abstract: The purpose of this study was to determine the effect of a 6-week training program on the physical fitness of young women. The subjects were 18 female students who participated in a supervised exercise program consisting of aerobic and strength training exercises. Physical fitness was assessed at baseline and after 6 weeks using a series of standardized tests. Results showed significant improvements in cardiovascular endurance, muscular strength, and body composition over the 6-week period.
