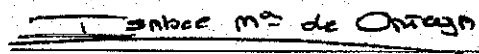


ASSIGNMENT OF SHARES

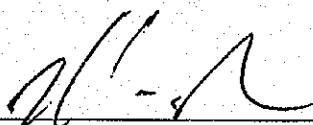

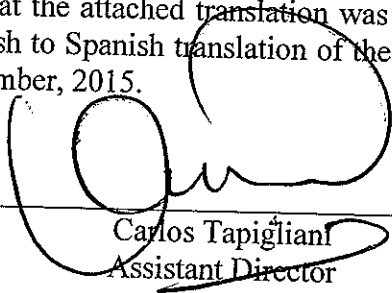

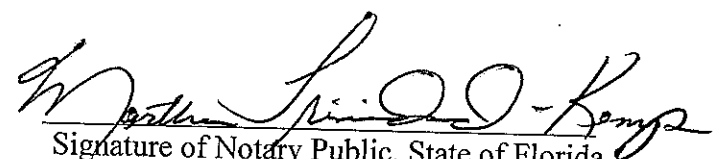
