The Gobernación proposed this to the ministry, and it took effect on 10/1/11, without having informed the latter, which had been given 15 days to receive a formal comment. This proposal presents problems as regards the procedure of public notice (according to Law 10/2009), although nothing happens, it seems.

In this, PUBLIPOINT claimed that the Gobernación was committing an arbitrary modification to the law by introducing a new interpretation, separate to the original, of the Article 200 of the Law of Services, Article 100(2) of the Law of General Services, of which the former article has an amendment by which the Public Supply Agency can't take decisions, the latter, between Public Services, does not according to Article 100(2) have the right to do so, and thus PUBLIPOINT claims that this 2010 amendment, of the 2009 Standard Project Report, does not allow, or does not prevent, the creation of different mechanisms to manage the public supply, such as the Gobernación claims, in order to avoid the so-called "service oligopoly" mentioned in the resolution, or force the administration to implement its requirements under the Law. In both cases, PUBLIPOINT argues in order to file the following motions:

- 1.- Informe de Riesgos Generales de la Comisión por el año 2010.

Primer Punto

The problem is that Article 200 refers to the Gobernación General, so there is no scope for separate interpretations, being the Gobernación General's function to define the interpretation.

Segundo Punto

The problem is the nature of authority of the Gobernación, as a body of higher than executive importance, being at the General Council's highest position (see comments).

Tercer Punto

If the Gobernación does a reservation on the Gobernación Autónoma of Services de Gobernación, because the Gobernación integral, because the Pleno and Plenaria of which are the highest level of government, corresponds to the former reserve of defining policy on services.

In such case, PUBLIPOINT agrees to withdraw the Second Point above.

Cuarto Punto

Below is included the resolution of 2010, and below the last Gobernación's response to the consultation of services in 2010, 100% participating. Considered appropriate to receive input, and the date of writing of this document is the earliest evidence of public participation, since previous documents are distributed to each one separately per government.


