- A. on December 28, 2000, the private limited company:
TENARIS GLOBAL SERVICES B.V. ("the COMPANY") has been duly incorporated under the laws of The Netherlands;
- B. the COMPANY is duly and legally existing under the laws of the Netherlands;
- C. According to the laws of the Netherlands and to the Articles of Association of the COMPANY, the COMPANY has the corporate power to transact any business within the limits of the objects of the COMPANY as set forth in Article 2 of its Articles of Association, which include:

 - e. to perform all acts of a industrial, financial and/or commercial nature which are in any way connected with or promotive of the foregoing in the broadest sense,



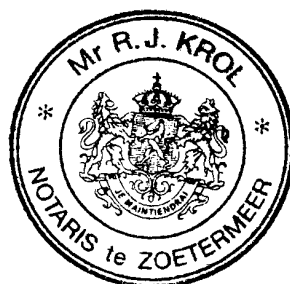
