

SOLICITUD DE ACCESO Y DECLARACIÓN DE RESPONSABILIDAD

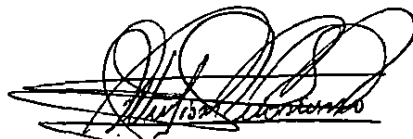
