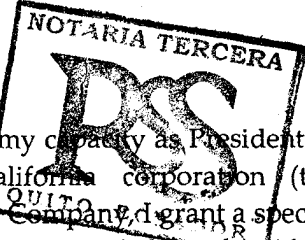

POWER OF ATTORNEY



PROVEN BY THIS INSTRUMENT, I, Ronald D. Dickel, in my capacity as President of **INTEL MICROPROCESSOR CORPORATION**, a California corporation (the "Company") duly authorized by law and the statutes of the Company, grant a special power to Mr. Santiago Reyes, Colombian Citizen, marital status married, legal resident in Quito, Ecuador, fluent in Spanish and able to contract and bind on behalf of the company before any governmental authority, within the limits and Ecuadorian jurisdiction in order to perform the following acts:

- a) Represent the Company in all of its acts; legal, corporate, civilian and any business in the Republic of Ecuador.
- b) Appear on behalf of the Company before any authority, private or public entity, in the Republic of Ecuador.
- c) Respond to any claims and legal and administrative actions, at all instances, that any public or private entity can interpose against the Company; present any petition or ask any kind of action on behalf of the company within the Republic of Ecuador.
- d) Comply with all the legal obligations and regulations imposed by the Law of Companies of the Republic of Ecuador (Ley de Compañías del Ecuador). Mr. Santiago Reyes may submit on behalf of the grantor Company all reports and documents that the "Superintendencia de Compañías" or any other control entity may require.
- e) Mr. Santiago Reyes shall have the broadest faculties for the exercise of this power, and will not be personally accountable for any of the obligations of the grantor Company.

This Power of Attorney specifically excludes the conduct of any banking, borrowing or securities related activity.

This Power of Attorney shall remain in full force and effect until December 31, 2012, unless earlier revoked in writing or upon the termination of the employment of POA Recipient from Intel Corporation, or any of the direct or indirect subsidiaries of Intel Corporation.

The attorney may not substitute any of the entitlements granted by this power, or delegate all or any part of this power without permission of the grantor.

The performance of any action in the exercise of this power shall be considered accepted by the grantor.

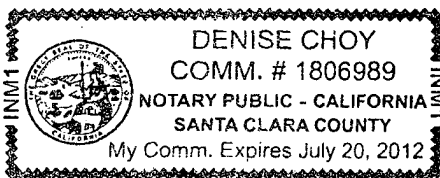

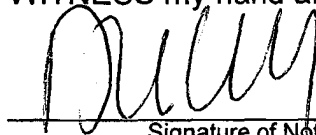
