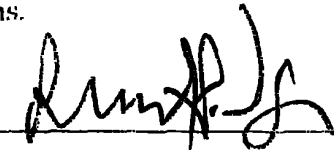


POWER OF ATTORNEY

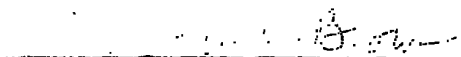

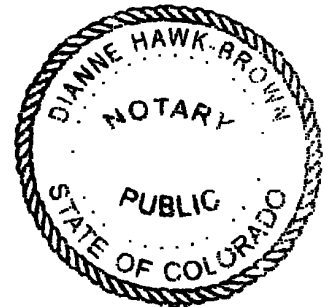

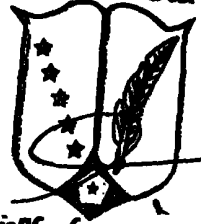
