## PODER ESPECIAL / POWER OF ATTORNEY COMPAÑIAS / COMPANIES

Sasha Mandakovic Falconi, con cédula de ciudadanía No. 1709216392, y/o Braulio Guillermo Quiñónez Abril, con cédula de ciudadanía No. 159788, todos ellos mayores de edad, de estado civil casados, de profesión abogados e ingeniero en el caso del último, domiciliados en la ciudad de Quito - Ecuador, para que actuando a nombre de la otorgante la represente ante cualquier entidad, autoridad o persona, natural o jurídica, pública o privada, especialmente ante las del orden Administrativo, Contencioso-Administrativo, Judicial o Extra Judicial, en todo lo referente a los siguientes asuntos:


1. Solicitar y obtener el correspondiente registro de inversión extranjera, autorizaciones para la remesa de ganancias, y reinversión o dividéndos no distribuidos u otro excedente de capital, o reexportar el capital invertido o reinvertido. Generalmente para llevar a cabo, en representación del otorgante toda clase de acciones relacionadas con la inversión extranjera en la República del Ecuador.
2. Comparecer a reuniones de Junta General de Socios, ordinarias o extraordinarias de la compañía Rockwell Automation Ecuador Cia. Ltda., de la cual el otorgante es socio o accionista, y tomar las correspondientes decisiones y suscribir las Actas o cualquier documento necesario para perfeccionar las decisiones tomadas en dichas Juntas.
3. Ejercer Procuración Judicial, y ratificar o no la agencia oficiales.
4. Expressamente se otorga este Poder amplio y suficiente, para ejercer las facultades especiales establecidas en el Art. 44 del Código de Procedimiento Civil, esto es: conciliar, transigir, comprometer el pleito en árbitros, desistir del pleito, deferir al juramento decisorio, absolver posiciones; y, recibir la cosa sobre la cual verse el litigio o tomar posesión de ella. Los mandatarios podrán ejecutar cualquier otro acto que requiera de cláusula especial; para cualquiera y/o todas las disposiciones que se mencionan en este instrumento.
5. Se deja expresa constancia que las facultades enumeradas en este mandato son meramente ejemplificativas y no limitativas de otras facultades implícitas, por cuyo motivo, los mandatarios están autorizados a ejercer, sin restricción alguna, todos los derechos de acuerdo con la Ley vigente y/o con la legislación que se promulgue en el futuro, se relacionen y/o emerjan y/o sean consecuencia del objeto del presente Poder y en razón de lo aquí expresado.

The undersigned, Karen A. Balistreri, a citizen from the United States of America, an attorney, from the United States of America, domiciled at 1201 South Second Street Milwaukee, Wisconsin, 53204, by the rights that I represent in my capacity as Vice President, Assistant Secretary, and Legal Representative of **ROCKWELL AUTOMATION INTERNATIONAL HOLDINGS, LLC** (the "Company"), an organization existing and organized under the laws of the United States of America, and in present execution of its social objective, domiciled at 1201 South Second St., Milwaukee, WI 53204, and a position to which I was appointed on February 5, 2010 by the Company's Board of Directors ; do hereby grant **POWER OF ATTORNEY** to Carlos Morales Bernal, with identification number No. 171006187-8, Cecilia Falconi Pérez, with identification number 1704611449 and/or Lucía Cordero Ledergerber, with identification number 1711102739 and/or Carlos Alberto Arroyo del Río, with identification number 1707264698 and/or Sasha Mandakovic Falconi, with identification number 1709216392, and/or Braulio Guillermo Quiñónez Abril, with identification number 159788, all of them citizens from Ecuador, attorneys, except for the latter, who is an engineer, domiciled in Quito - Ecuador, who can act on the grantors' behalf before any entity, authority or person, public or private, especially before those Administrative, Contentious-Administrative, Judicial or Extra-Judicial, in all matters concerning the following:

1. To request and obtain the corresponding registrations of foreign investments, authorizations for the remittance of profits, and reinvestment or non distributed dividends or other capital surplus, or to re-export the invested or reinvested capitals. Generally, to carry on, on behalf of the grantor, all kind of actions in connection with the foreign investment in the Republic of Ecuador.
2. To attend General Share or Stockholder's Meetings, ordinary or extraordinary, of the company Rockwell Automation Ecuador Cia. Ltda., of which the grantor is a shareholder, and taking the concerning decisions, as well as subscribe acts and other documents required to comply by the decisions taken at the Shareholder meeting.
3. Judicial proxy and to ratify or not the officious agency.
4. It is expressly granted full and ample **POWER OF ATTORNEY** to exercise the special rights established under Art. 44 of the Civil Procedure Code, this is: to conciliate, settle, submit to arbitration, desist legal proceeding, defer the harmonious testimony or decisive oath, absolve or acquit positions; and to receive the object related to the litigation or to take possession of the said object. Proxies may execute any other act that requires a special clause; for any and/or all the provisions mentioned in this instrument.
5. It is expressly stated that attributions enumerated in this Power of Attorney are merely explanatory and not *limitative of other powers*, and therefore, the attorneys -in fact- are authorized to exercise without any restriction whatsoever, all the rights granted by the law or emerging from it or which may be a consequence of the objects of this mandate and whether this be under legislation at present in force or legislation which may be promulgated in the future in order that this mandate be sufficient enough for all the matters referenced above.
