SPECIAL POWER OF ATTORNEY

I, Kent Boyce, in my capacity as legal representative of **AGI Traffic Technology Inc.**, a company established under the laws of Canada, hereinafter referred to as the "Company" or "AGI", for the legal purposes stipulated in Ecuador's Companies Law, the Company grants this special power of attorney to PH REPRESENTACIONES CIA LTDA., an Ecuadorian Legal Entity, hereafter referred to as the "Attorney-in-Fact", to perform the following:

- (a) Act as the Company's attorney-in-fact in accordance with what is stipulated in Article 6 of Ecuador's current Companies Law, in the matters limited to the representation of AGI as shareholder of the Ecuadorian companies.
- (b) Answer lawsuits and comply with the obligations that the Company acquires in the Republic of Ecuador, limited to the matters related to its position as shareholder of any Ecuadorian Company.
- (c) Represent the Company in the general meetings of the Shareholders of any Ecuadorian Company.

In accordance with the last paragraph of Article 6 of the Companies Law, the Attorney-in-Fact shall not be responsible for compliance with the Company's obligations.

This Special Power-of-Authority will be valid since April 16, 2009.
