

## SPECIAL POWER OF ATTORNEY



I, Kent Boyce, in my capacity as legal representative of AGI Traffic Technology (1977) QUIT a company established under the laws of Canada, hereinafter referred to as the "Company" or "AGI", for the legal purposes stipulated in Ecuador's Companies Law A SEXTA the Company grants this special power of attorney to PH REPRESENTACIONES AND QUITO LTDA., an Ecuadorian Legal Entity, hereafter referred to as the "Attorney-in-Fact", to perform the following:
