DISCUSSION AND CONCLUSIONS

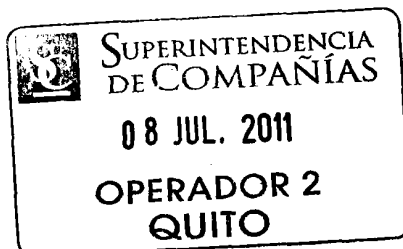

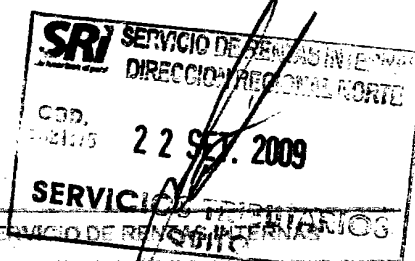
