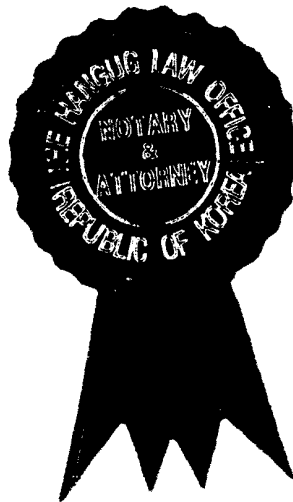

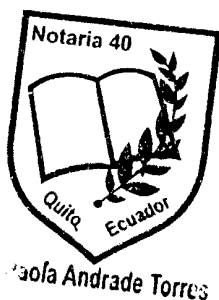
POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: that, I, the undersigned, KWANG-CHUL CHOI, as President and CEO of SK Engineering & Construction Co. Execute all acts and declarations of will required for the Ecuadorian corporation or Sociedad Anónima, SKE&C CONSULTORES ECUADOR S.A., such as, but not limited to, drafting and signing of the public deed, as well as any other actions required for SKE&C CONSULTORES ECUADOR S.A., which corporate objective will primarily consist in the execution of Studies and Consulting Activities.
2. Execute and vote on the Meeting of Shareholders of SKE&C CONSULTORES ECUADOR S.A., for to appoint the Directors, if so required in the bylaws, and Legal Representatives of SKE&C CONSULTORES ECUADOR S.A., at his sole discretion.
3. Open and operate on bank accounts, in its name, to endorse or deposit to its credit in said banks, checks, drafts, moneys, notes and other evidence of value; to draw and sign checks in his name against such deposits for such moneys as may be necessary from time to time in the transaction of such business.

THIS POWER OF ATTORNEY shall become null and void upon the date on which it is expressly revoked by SK E&C.

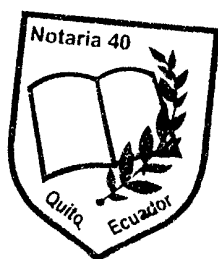

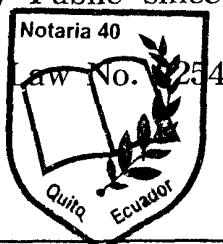

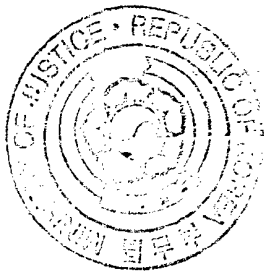
