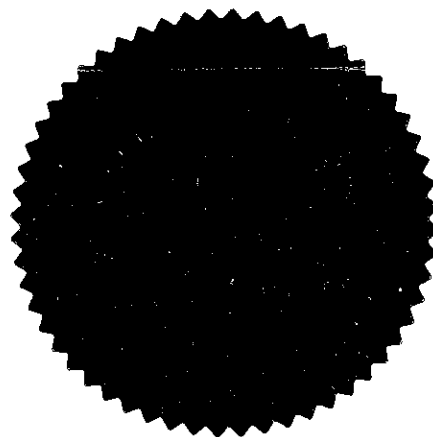

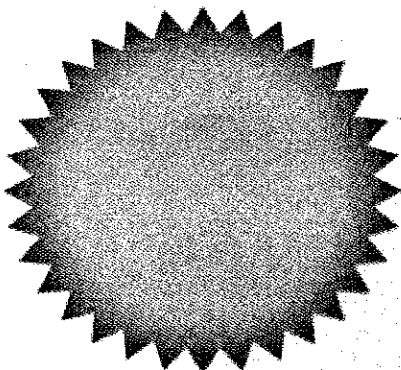

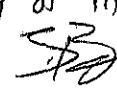

[Canada], March [17], 2017. Mr. Seung Bae Sung General Manager SKE&C CONSULTORES ECUADOR S.A. Quito, Ecuador We hereby authorize and delegate Mr. Seok Ho Hyun (hereinafter known as the "Attorney-in-fact") to represent SUNLAKE CO.
