POWER OF ATTORNEY

In the event of a discrepancy between Spanish and English versions of this document, the Spanish version shall prevail.

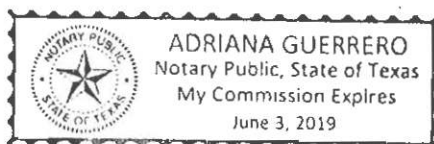

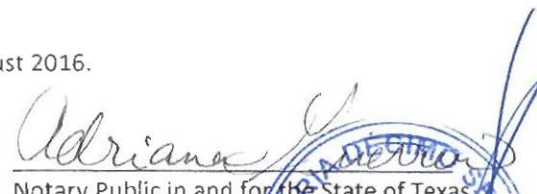

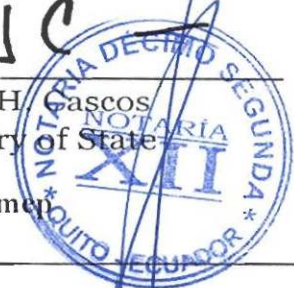
