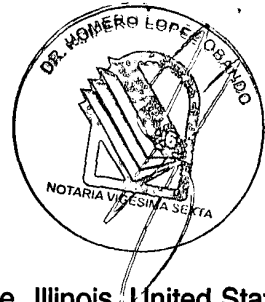

SPECIFIC POWER OF ATTORNEY

- c) On behalf of the PRINCIPAL, the AGENT shall undertake all necessary procedures in order to fully accomplish the assignment conferred within this instrument and safeguard its rights and interests. No Ecuadorian authority, whether governmental or private, may claim lack of legal capacity to handle assigned matters.

The PRINCIPAL acknowledges and accepts that the AGENT shall not be held personally liable of the responsibilities acquired by the PRINCIPAL.

This Power of Attorney shall remain valid and effective until October 26, 2012; but may be revoked at any time by the PRINCIPAL.-

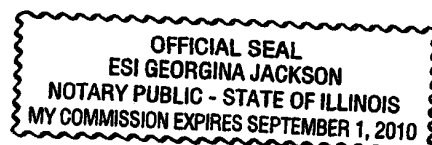

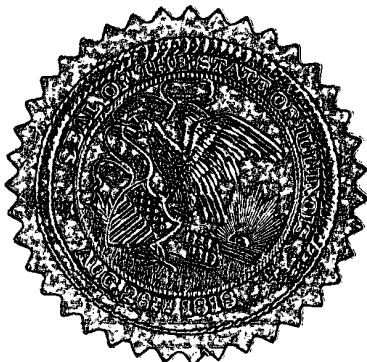
