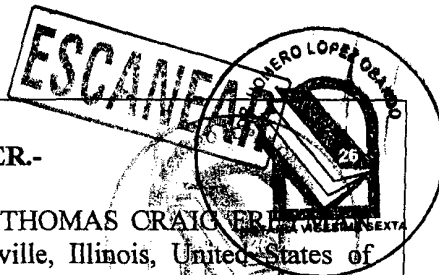
SPECIFIC POWER.-

I, the undersigned THOMAS CRAIG FREYMAN, resident at Libertyville, Illinois, United States of America bearer of, Passport Number 027707611 of American nationality, in my capacity as Manager of ABBOTT EQUITY INVESTMENTS LLC ("the PRINCIPAL") freely and voluntarily hereby grants this Specific and Limited Power of Attorney to Jessica Gellibert and appoints her as "Attorney-in-fact", hereinafter also referred to as "AGENT", so that she shall have the full power and authority, in the name and on behalf of the PRINCIPAL, to undertake and perform only the following acts:

No Ecuadorian authority, whether governmental or private, may claim lack of legal capacity to handle assigned matters.

The PRINCIPAL acknowledges and accepts that the AGENT shall not be held personally liable of the responsibilities acquired by the PRINCIPAL.

This Power of Attorney shall remain valid and effective until October 27th, 2015, but may be revoked at any time by the PRINCIPAL.-

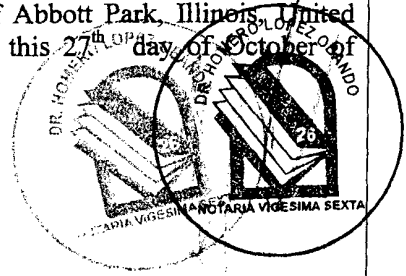
