





**DESIGNA**, a la compañía CEVALLOS CASALS & BALSECA ABOGADOS CC&B CIA. LTDA., de nacionalidad ecuatoriana, con RUC No. 1792600804001, con domicilio en la ciudad de Quito, Ecuador, como nuestra Mandataria, en adelante denominado simplemente como la "Apoderada", para que a nombre y en representación de CONTINUOUS STATIONERY LIMITED, realice los siguientes actos:

**Primero-** En calidad de representante de la Mandante, comparezca en Juntas de Accionistas, ordinarias o extraordinarias, de la compañía ecuatoriana ADAREINTERNATIONAL DEL ECUADOR S.A., ordinarias o extraordinarias.

La Apoderada en las Juntas de Accionistas tendrá plenas facultades para conocer, votar y decidir sobre las decisiones que la Mandante, en calidad de accionista de ADAREINTERNATIONAL DEL ECUADOR S.A., le corresponda tomar en las juntas referida.

Sin embargo, de conformidad con lo dispuesto en el último inciso del artículo seis (6) de la Ley de Compañías, la Mandataria no será personalmente responsable del cumplimiento de las obligaciones de la Mandante.

EL PODER ESPECIAL que se confiere por este instrumento será ejercido por la Mandataria, para realizar los actos antes descritos, en cualquier lugar dentro de la República del Ecuador. Por lo cual ninguna autoridad pública o privada podrá alegar falta o insuficiencia de poder. El presente poder podrá ser delegado a cualquier persona.

**DECLARO** que este poder especial tendrá plena fuerza y efecto hasta su revocatoria formal. Sin embargo de lo cual, la Mandataria podrá renunciar a dicho poder especial y/o la Mandante podrá revocarlo a su solo arbitrio y voluntad, sin que exista ningún pago de daño o perjuicio por concepto de dicha revocatoria o renuncia.

## POWER OF ATTORNEY

Mr. RAYMOND PHILLIP BERRY, being on behalf of CONTINUOUS STATIONERY LIMITED a company duly incorporated under the laws of England, having its principal address at Shakespeare Martineau Two Colton Square, Leicester, England, hereafter referred as "The Grantor", hereby grants a Power of Attorney under the terms as stated herein.

**APPOINTED**, CEVALLOS CASALS & BALSECA ABOGADOS CC&B CIA. LTDA., Ecuadorian Company, Tax ID No. 1792600804001, domiciled in Quito, Ecuador, as our Attorney in Fact, hereafter referred as "the Attorney", to act in the name and on behalf of CONTINUOUS STATIONERY LIMITED, to perform the following acts:

**First-** In its capacity of representative of the Grantor, act in the Shareholders Meetings, ordinary or extraordinary, of the Ecuadorian company ADAREINTERNATIONAL DEL ECUADOR S.A.

The Attorney in the shareholders meetings has plenty powers to know, vote and decide on the decisions that the Grantor, in its capacity of shareholder of ADAREINTERNATIONAL DEL ECUADOR S.A. may take place in such meetings.

**Second.** - To act in the name and on behalf of the Grantor, according to Article Six (6) of the Companies Law of Ecuador. Therefore, the Attorney may answer claims and perform the obligations of the Company undertaken in Ecuador. Nevertheless, the Attorney will not be personally responsible for the compliance Grantor's obligations.

The **POWER OF ATTORNEY** herein granted, shall be exercisable by the Attorney, to perform the action described above, in any place within the Republic of Ecuador. Therefore no public or private authority may argue lack of power. This Power of Attorney shall be delegate to any person.

I **DECLARE** that this Power of Attorney shall be full force and effect from its signature and will be valid until its formal revocation. However, the Attorney may waive this Power of Attorney and/or the Grantor may revoke it, in as sole discretion and will no claims or payments may result from such resignation or recall.
