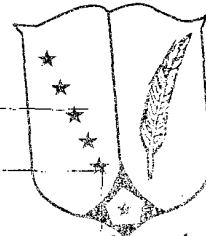

**SPECIAL POWER OF ATTORNEY**

The Principal Fresenius Medical Care Beteiligungsgesellschaft mbH, duly represented by Dr. Emanuele Gatti and Dr. Rainer Runte as Managing Directors, hereby grants a Special Power of Attorney to Diego Pérez-Ordóñez, Juan Manuel Marchán and Juan Gabriel Reyes, Ecuadorian lawyers, married, of legal age (the "Attorneys-in-fact") so that they may, individually or jointly, do the following on behalf of the Principal:

- (1) Represent the Principal in front of third parties pursuant to Article 6 of the Law on Companies for purposes of the amendments introduced by Article 1 of Law No. 0 published in Official Register No. 591 dated May 15, 2009.
- (2) Answer claims on behalf of the Principal, and comply, on behalf of the Principal, the obligations set forth in the Law on Companies, but without understanding due to this fact that the Principal is to be considered a permanent establishment in Ecuador, and the Principal shall not be obligated to establish itself in Ecuador or to register itself with the Taxpayers' Registration or to file income tax returns. The Attorneys-in-fact for no reason whatsoever shall be responsible for the Principal's obligations.
- (3) Additionally, the Attorneys-in-fact shall represent the Principal at the Shareholders Meetings of the Ecuadorian companies of which the Principal is or may be a shareholder or partner.

PODER ESPECIAL

La Poderdante, la compañía Fresenius Medical Care Beteiligungsgesellschaft mbH, representada por Dr. Emanuele Gatti y Dr. Rainer Runte en su calidad de Directores, por este medio otorga poder a favor de Diego Pérez Ordóñez, Juan Manuel Marchán y Juan Gabriel Reyes, abogados, ecuatorianos, casados, ciudadanos ecuatorianos y mayores de edad, (los "Apoderados"), para que éstos de forma individual o colectiva pueda a nombre de la Poderdante:

- (1) Representar a la Poderdante frente a terceros, de acuerdo con el Art. 6 de la Ley de Compañías a efectos de las reformas introducidas por el Art. 1 de la Ley No. 0, publicada en Registro Oficial 591 de 15 de mayo del 2009.
- (2) Contestar demandas a nombre de Poderdante y cumplir, a nombre de la Poderdante, las obligaciones establecidas en la Ley de Compañías para las empresas extranjeras socias de compañías ecuatorianas, sin que por ello deba entenderse que la Poderdante será considerada como establecimiento permanente en el país, ni estará obligada a establecerse en el Ecuador, ni a inscribirse en el Registro Único de Contribuyentes, ni a presentar declaraciones de impuesto a la renta. Los Apoderados por ningún motivo serán personalmente responsables de las obligaciones del Poderdante.
- (3) Adicionalmente los Apoderados representarán al Poderdante en las Juntas de Accionistas de las compañías ecuatorianas de las que el Poderdante sea o llegue a ser accionista o socio.

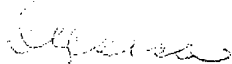

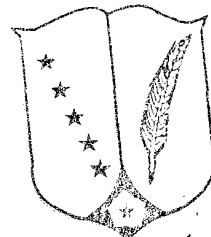
