Purpose: The company's purpose is to participate in enterprises in Switzerland and abroad, particularly in the food industry, to establish, acquire and develop such enterprises, to acquire shares, bonds and other securities of such enterprises, to resell or otherwise dispose of acquired participations and securities; may acquire, encumber or sell real estate

Specific matters of fact:  
 Merger: Cross-border takeover of the assets and liabilities of "Nestlé's Holdings Limited", in Nassau (BS), a Limited Company according to the laws of the Bahamas, according to the merger agreement of June 30, 2005 and the balance sheet as of December 31, 2004. Assets of CHF 52'047'871.00 and liabilities (credit capital) of CHF 195'000.00 have been transferred to the acquiring company. The shareholders of the transferring company received 3'200 shares at CHF 12.50. The share capital has been increased by CHF 40'000.00 as a consequence of this merger. New share capital: CHF 100'000.00 (previous CHF 60'000.00).  
 Merger: Takeover of the assets and liabilities of "Mystis participations S.A.", in Lausanne (CH-550.1.007.956-7), according to the merger agreement of December 7, 2005 and the balance sheet as of September 30, 2005. Assets of CHF 6'322'012.00 and liabilities (credit capital) of CHF 792'945.00 have been transferred to the acquiring company. As the acquiring company holds all the shares of the transferring company, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.  
 Merger: Takeover of the assets and liabilities of Somep AG, in Stettlen (CH-035.3.009.563-6), according to the merger agreement of June 13, 2007 and the balance sheet as of December 31, 2006. Assets of CHF 216'425.00 and liabilities (credit capital) of CHF 3'598.00 have been transferred to the acquiring company. As both merged entities are being fully held by the same shareholder, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.

Merger: Takeover of the assets and liabilities of Carnex SA, in Châtel-Saint-Denis (CH-232.0.730.140-5), according to the merger agreement of June 12, 2007 and the balance sheet as of December 31, 2006. Assets of CHF 3'708'000.00 and liabilities (credit capital) of CHF 406'000.00 have been transferred to the acquiring company. As the acquiring company holds all the shares of the transferring company, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.

Merger: Takeover of the assets and liabilities of Cadipro Holdings SA, in Vevey (CH-550.1.032.525-9), according to the merger agreement of June 11, 2007 and the balance sheet as of December 31, 2006. Assets of CHF 81'891'000.00 and liabilities (credit capital) of CHF 1'893'000.00 have been transferred to the acquiring company. As both merged entities are being fully held by the same shareholder, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.

Merger: Takeover of the assets and liabilities of Société Anonyme Peter Cailler, Kohler, in La Tour-de-Peilz (CH-550.0.119.120-7), according to the merger agreement of December 13, 2007 and the balance sheet as of September 30, 2007. Assets of CHF 89'531.00 and liabilities (credit capital) of CHF 52.00 have been transferred to the acquiring company. As both merged entities are being fully held by the same shareholder, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.

Merger: Takeover of the assets and liabilities of Spega SA, in Fribourg (CH-217.0.131.219-3), according to the merger agreement of June 20, 2008 and the balance sheet as of December 31, 2007. Assets of CHF 17'650'027.00 and liabilities (credit capital) of CHF 16'417.00 have been transferred to the acquiring company. As both merged entities are being fully held by the same shareholders, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.

Merger: Takeover of the assets and liabilities of Nidex S.A., in La Tour-de-Peilz (CH-550.0.118.380-2), according to the merger agreement of December 19, 2008 and the balance sheet as of September 30, 2008. Assets of CHF 7'530'130.00 and liabilities (credit capital) of CHF 653'827.00 have been transferred to the acquiring company. As both merged entities are being fully held by the same shareholder, there has neither a capital increase nor an allocation of shares taken place as a consequence of this merger.
