



## SPECIAL POWER OF ATTORNEY

The undersigned, Mr. Jens Bjerg Sørensen and Mr. Jørn Ankær Thomsen, acting jointly in their capacity as duly authorized representatives of **BIOMAR GROUP A/S** (hereinafter, also the “**Grantor**”), a company duly incorporated and existing under the laws of Denmark, with its corporate domicile at Værkmestergade 25, 6 floor, 8000 Aarhus, Denmark, hereby grants a special Power of Attorney, as broad and sufficient as required by law, in favor of:

## PODER ESPECIAL

- D. Niels-Henrik Aarestrup Nielsen, mayor de edad y de nacionalidad danesa, soltero, con domicilio profesional sito en Værkmestergade 25, piso 6, 8000 Aarhus, Dinamarca, y con número de Pasaporte 208045433, actualmente en vigor;

in order that any of them (the “**Proxy holder**”), individually, may carry out the following acts, in the name and on behalf of the Grantor, in the terms and conditions that the Proxy holder may deem appropriate and in the best interest of the Grantor:

1. Represent the Grantor, according to the Ecuadorian Companies Act, particularly in accordance with its Article 6; and, in general, sign or execute documents, petitions, forms or any other documents and take the steps or proceeding necessary, related to the annual foreign shareholders report to be filed by ALIMENTSA S.A. before the Superintendency of Companies, Securities and Insurance, where the Grantor is a foreign shareholder of an Ecuadorian company; and,
2. Act on behalf of the Grantor at the Shareholders Meetings of the Ecuadorian commercial company ALIMENTSA S.A.

The Grantor shall indemnify and hold the Proxy holders harmless against any and all reasonable costs, claims and liabilities which the Proxy holder s may incur as a result of any action taken by the Proxy holders in the proper exercise of any of the powers and authority conferred, or purported to be conferred, on them by this Power of Attorney, except where such costs, claims or liabilities arise out of the Proxy holders’ gross negligence, fraud, default, or wilful misconduct.

This instrument shall be governed by the laws of the Republic of Ecuador, and be in force for five (5) calendar years since its execution date.

2. Actuar a nombre de la mandante en las Juntas Generales de Accionistas de la sociedad mercantil ecuatoriana ALIMENTSA S.A.

El Poderdante indemnizará y mantendrá indemnes a los Apoderados por cualesquier costes, reclamaciones o responsabilidades que razonablemente se pudieran derivar para los mismos como consecuencia de las actuaciones de los Apoderados en el ejercicio propio de los poderes conferidos en este Poder Especial, con excepción de aquellos costes, reclamaciones o responsabilidades que surjan como consecuencia de negligencia grave, vicio, falta o dolo de los Apoderados.

Este instrumento se regirá por las leyes de la República del Ecuador, y estará vigente por cinco (5) años desde la fecha de su suscripción.

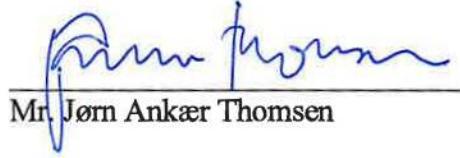

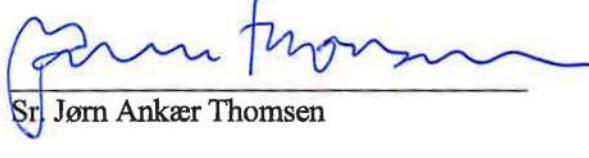
