The Attorney-in-fact is hereby authorized and empowered to represent the Company through its individual signature, exercising the functions set forth in article 6 of the Law on Companies, acting solely and exclusively for the benefit of the Company, for the purpose of:

- (i) Making declarations, statements or certifications on behalf of the Company in order to certify and warrant the legal existence of the Company,
- (ii) Certifying the constitutional documents of the Company (including, but not limited to, the Company's bylaws),
- (iii) Represent the Company before the Ecuadorian courts in any legal and judicial actions,
- (iv) Represent the Company in any shareholders meeting of any Ecuadorian Company in which Puffer Latin America Inc. is a shareholder.

The Attorney in Fact is hereby authorized to represent the Company before any notary, embassy, consulate, agencies and other governmental authorities in Ecuador and more generally to take all legal actions convenient or

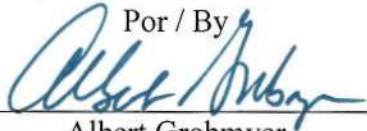

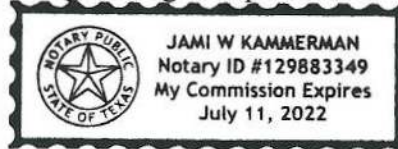
