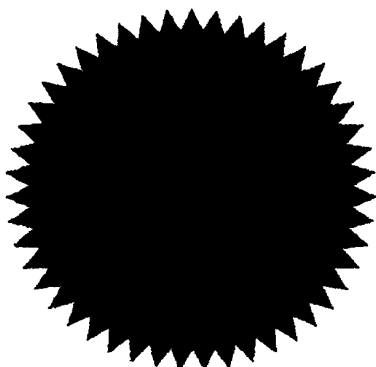

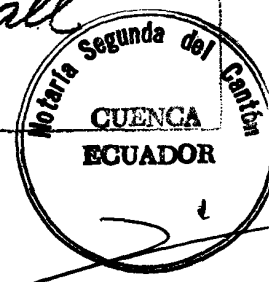

Power of Attorney

Jurch, III in his capacity as Secretary of the Board as evidenced by means of the attached instrument conferring a power of attorney upon Mr. Rafael Marcelo Chico Cazorla, attorney at law, Ecuadorian, having his address at Ciudad de Cuenca, ID Card No. 0100852714; such document grants the most ample and sufficient power to act as follows:

1. To represent his principal under the terms of article 6 and paragraph 3 of article 415 of the Ecuadorian Business Corporations Act, having all powers to perform all actions and execute agreements to be entered into and to be effective at Ecuadorian territory, specially to answer complaints and perform all the obligations assumed;

2. To exercise the rights inherent to his principal as shareholder of Compañía Ecuatoriana del Caucho, S.A., ERCO and any other company having its address in Ecuador in which it participates or owns shares or capital stock, including the authority to represent such companies at the general meetings of partners and shareholders.

3. To purchase shares or stock in companies organized in Ecuador, in such event, the attorney-in-fact shall require written instructions from his principal to perform each transaction;

The attorney-in-fact may substitute this power of attorney in full or in part.

This instrument shall prevail over any prior power of attorney granted to any individual to act on behalf of the company within Ecuadorian territory.
