## POWER OF ATTORNEY

Among the special powers mentioned above, it shall be understood that such powers that representatives of a foreign investor have or should have pursuant to the laws, regulations or decisions of a governmental authority are embodied into this power-ofattorney, wholly or partially, pursuant to legal provisions and requirements, without involving a waiver to this power-of-attorney.

This power of attorney has been executed in New Castle, Delaware on March 19, 2008.
