PROXY

Mr. Johannes van der Dussen in behalf and in representation of ORIFLAME KOSMETIEK B.V. declares:

FIRST.- APPEARERS.-

Mr. Johannes van der Dussen, appears as legal representative of ORIFLAME KOSMETIEK B.V. legally formed under the laws of Netherlands which hereinafter will be simply called "THE MANDANT", who freely and by his own will through the present hereby grants a Proxy on behalf of JOSE RAFAEL MEYTHALER BAQUERO, MARGARITA ZAMBRANO ALBUJA Y CATALINA VÁSCONEZ BASSANTE, who hereinafter will be simply called "REPRESENTATIVES", for acting jointly or individually, represent the MANDANT in the Republic of Ecuador.

SECOND.- SCOPE OF THE MANDANT.-

The REPRESENTATIVES have the capacity of representing the MANDANT within all the acts and contracts derived from their capacity of member of ORIFLAME DEL ECUADOR S.A. of Ecuadorian citizenship in which the MANDANT has shares. For the fulfillment of this task, the REPRESENTATIVES will be able to carry out the necessary acts for executing the all the rights and fulfill with the obligations that correspond to the MANDANT as shareholder, specially: subscribe shares; appear before the General Shareholders Boards; file petitions to the Superintendent of Companies; present the information which they are obliged to according to the Ecuadorian laws, and as shareholders; register investments made by the MANDANT in the Central Bank of Ecuador.

The REPRESENTATIVES have the obligation of answering claims and intervening judicial and extra-judicially for defending the rights and interests of the MANDANT, in which case a lawyer can be hired; carry out and enter on behalf of the MANDANT, all the acts and contracts required before the entities and/or competent, judicial, administrative, public, semi public or private authorities of Ecuador, since they have the highest faculties.

In general, the REPRESENTATIVES will be able to carry out, on behalf of the MANDANT, everything that is necessary for fulfilling the granted mandate and for protecting the rights and interests of the MANDANT, for which no public nor private authority of Ecuador could allege insufficiency of proxy. The REPRESENTATIVES for no reason will be personally responsible of the obligations of the MANDANT, according to what is disposed by article 1 of the Reformatory Law to the Law of Companies of Ecuador, published on the Official Register No. 591 of May 15th, 2009.

THIRD.- FORMALITIES.-

According to what is disposed on article 1 of the Reformatory Law to the Companies Law of Ecuador, published on the Official Register No. 591 of May 15th, 2009, the present proxy shall not be either registered or published by the media within the Ecuadorian territory.

FOURTH.- TERM.-



