## WRITTEN CONSENT OF THE BOARD OF DIRECTORS OF SYLVANIA S.A.N.V.

We, the undersigned, being all of the members of the Board of Directors of SYLVANIA S.A. N.V., a corporation duly organized under the laws of the Netherlands Antilles, pursuant to the authority granted by the Bylaws, hereby consent and agree to the adoption of the following resolutions effective as of October 28, 2004,

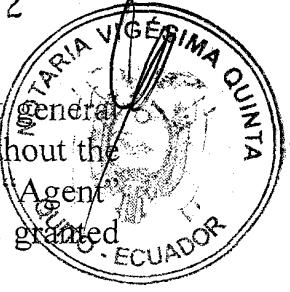
RESOLVED, that Equity Trust (Curaçao) N.V. in it's capacity as legal representative of SYLVANIA S.A. N.V. is hereby authorized to appear before a Notary Public and in the Company's name and on its behalf to grant a General Power of Attorney in favor of **Mr. German Enrique Jaime Serrano**, holder of the Colombian citizenship card No. 13.836.453, constituting him as the true and lawful General Attorney-in-Fact of the Ecuadorian Branch of SYLVANIA S.A. N.V. (hereinafter the Branch) in the Republic of Ecuador and conferring all powers required to carry out the following acts on behalf and in the name of the Branch in the Republic of Ecuador.

ONE: Act as General Agent of the "Branch" in the Republic of Ecuador and before its public and private entities, courts of law with such ample and sufficient powers as to comply with the Laws of Ecuador.

TWO: Perform all legal acts and matters that will take place in Ecuador with ample and sufficient powers; especially the ability to reply to all legal claims and demands and fulfill contractual obligations.

THREE: Sign contracts and agreements with customers, agents and representatives for the sale or leasing of products and services offered by the "Branch". Sign contracts and agreements for the purchase of supplies, services and materials used in the day to day business of the "Branch". This power includes the faculties contained in Art. 415 of the Law of Companies, therefore the "Agent" will have the faculties to perform all legal acts and business which are going to take place in Ecuador.

FOUR: Represent the "Branch" in public and private bids. Appoint general and special agents in order to work jointly or separately, with or without the right to assign the power of attorney and with the faculties that the "Agent" deems convenient. Revoke when deemed convenient, those powers granted to said agents.

FIVE: Open and maintain bank accounts, make deposits, withdrawals, endorsements of all kinds of securities and documents, receive monies from third parties and perform all acts related to the management and administration of the "Branch" in the Republic of Ecuador.

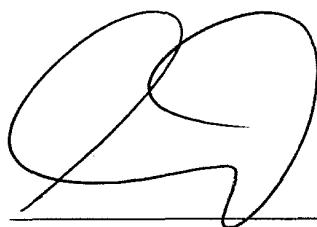

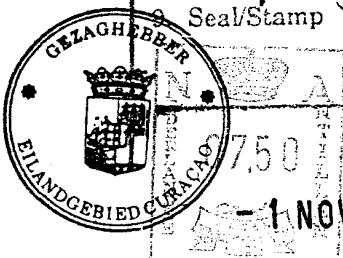

Este poder incluye las facultades contenidas en el Art. 415 de la Ley de Compañías, en consecuencia el “Apoderado” tendrá la facultad de realizar todos los actos legales y de comercio que vayan a tener lugar en el Ecuador.

CUARTA: Representar a la “Sucursal” en licitaciones y concursos públicos y privados. Designar representantes o apoderados generales o especiales con el fin de trabajar conjunta o separadamente, con o sin el derecho de ceder el poder de representación y con todas aquellas facultades que el “Apoderado” estime conveniente.
