En la ciudad de Omaha, Nebraska, a los días del mes de abril del 2014, el señor Scott W. Behrens a nombre y en representación de ACI WORLDWIDE IBERICA, S.L. IBERICA, S.L. declara:

PRIMERA.- COMPARCIENTES.-

Comparece el señor Scott W. Behrens, en su calidad de Director, y como tal, representante legal de ACI WORLDWIDE IBERICA, S.L., legalmente constituida bajo las leyes de Spain, con domicilio principal en la ciudad de Madrid, a la que en adelante se la denominará simplemente "LA MANDANTE", quien en forma libre y voluntaria a través del presente otorga poder a favor de TAROMEROCK S.A., compañía de nacionalidad ecuatoriana, a la que en adelante se la podrá denominar simplemente "MANDATARIA", para que a través de sus representantes legales, de forma individual o conjunta, represente a la MANDANTE en la República del Ecuador.

SEGUNDA.- AMBITO DEL MANDATO.-

La MANDATARIA está facultad para representar a la MANDANTE en todos los actos y contratos que se deriven de la calidad de accionista de compañías de nacionalidad ecuatoriana, en las cuales la MANDANTE posee acciones. Para el cumplimiento de este encargo podrán realizar todos los actos necesarios para ejercer los derechos y cumplir con las obligaciones que le correspondan a la MANDANTE en su calidad de accionista, en especial: suscribir certificados provisionales y títulos de acciones; comparecer a las Juntas Generales de Accionistas; presentar peticiones al Superintendente de Compañías; presentar la información a la que esté obligada según la legislación ecuatoriana, en calidad de accionista; registrar las inversiones que realice la MANDANTE en el Banco Central del Ecuador, entre otras.

La MANDATARIA tienen la atribución de contestar demandas e intervenir judicial y extrajudicialmente para defender los derechos e intereses de la MANDANTE; realizar y celebrar a nombre de la MANDANTE, todos los actos y contratos que se requieran ante las entidades y/o autoridades competentes, judiciales, administrativas, públicas, semipúblicas o privadas del Ecuador.

En general, la MANDATARIA podrá hacer, a nombre de la MANDANTE, todo aquello que sea necesario para cumplir a cabalidad con el mandato conferido y para proteger los derechos e intereses de la MANDANTE, por lo que ninguna entidad y/o autoridad pública o privada del Ecuador podrá alegar insuficiencia de

In the city of Omaha, Nebraska, on April 10th of 2014 on behalf of and representing ACI WORLDWIDE IBERICA, S.L. IBERICA, S.L. declares:

FIRST.- APPEARERS.-

Scott W. Behrens, appears as Director and as legal representative of ACI WORLDWIDE IBERICA, S.L., legally formed under the laws of Spain with statutory seat in the city of Madrid, which hereinafter will be simply called the "PRINCIPAL", who freely and by his own will through the present hereby grants a Proxy on behalf of TAROMEROCK S.A., an Ecuadorian company, which hereinafter will be simply called "REPRESENTATIVE", for acting jointly or individually by its legal representatives, represent the PRINCIPAL in the Republic of Ecuador.

SECOND.- SCOPE OF THE PRINCIPAL.-

The REPRESENTATIVE has the capacity of representing the PRINCIPAL within all the acts and contracts derived from their capacity of shareholder of Ecuadorian companies in which the PRINCIPAL has shares. For the fulfillment of this task, the REPRESENTATIVE will be able to carry out the necessary acts for executing the all the rights and fulfill with the obligations that correspond to the PRINCIPAL as shareholder, specially: subscribe shares; appear before the General Shareholders Boards; file petitions to the Superintendent of Companies; present the information which they are obliged to according to the Ecuadorian laws, and as shareholders; register investments made by the PRINCIPAL in the Central Bank of Ecuador and others.

The REPRESENTATIVE have the obligation of answering claims and intervening judicial and extra judicially for defending the rights and interests of the PRINCIPAL, in which case a lawyer can be hired; carry out and enter on behalf of the PRINCIPAL, all the acts and contracts required before the entities and/or competent, judicial, administrative, public, semi public or private authorities of Ecuador.

In general, the REPRESENTATIVE will be able to carry out, on behalf of the PRINCIPAL, everything that is necessary for fulfilling the granted mandate and for protecting the rights and interests of the PRINCIPAL, for which no public nor private authority of Ecuador could allege insufficiency of





TERCERA.- DURACION.-



The present Proxy is granted for an undefined time and will be valid until it is legally revoked.








