

Figure 1 shows the chemical structures of three compounds. Structure 1 is 1,2,3,4-tetrahydro-1,4-benzodioxane, a bicyclic ether with a benzene ring fused to a six-membered ring containing two oxygen atoms. Structure 2 is 1,2,3,4-tetrahydro-1,4-benzodioxane-2-thiol, which has a thiol group (-SH) at the 2-position of the six-membered ring. Structure 3 is 1,2,3,4-tetrahydro-1,4-benzodioxane-2-thione, which has a thione group (=S) at the 2-position of the six-membered ring.
