Este Poder Especial es otorgado el 9 de Febrero del 2010 por **Kuehne + Nagel International AG**.

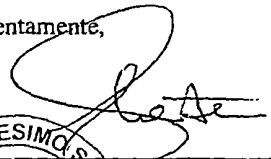

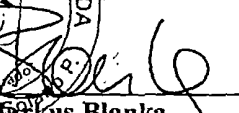

This Special Power of Attorney is made on February 9, 2010 by **Kuehne + Nagel International AG**.

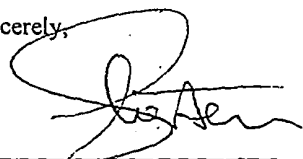

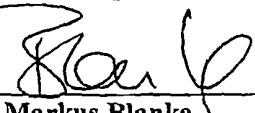
The Proxy, in any circumstance or reason, will be personally responsible of the Company's obligations.

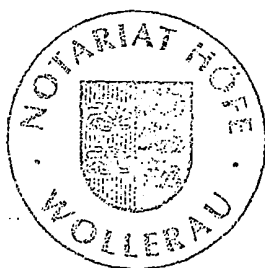

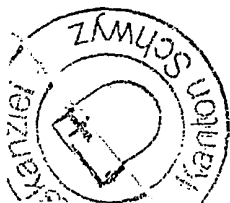
