

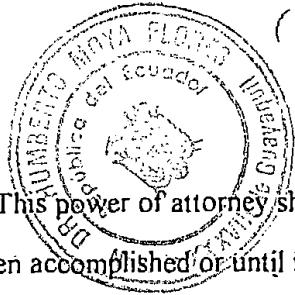
POWER OF ATTORNEY



Know all men by these presents that the undersigned, Lillian D. Williams, in her capacity as Vice President of Valvoline International, Inc., a corporation duly organized and existing under the laws of Delaware and having its principal offices at 3499 Dabney Dr., Lexington, KY 40509 (hereafter "VII"), hereby constitutes and appoints P B P Representaciones Cia. Ltda., Quito, Ecuador, to be VII's attorney-in-fact in Ecuador, with full power of substitution and revocation, authorizing them, in the name and on behalf of VII, to do the following:

1. To perform all acts and sign all documents which may be necessary in order to organize a corporation (sociedad anónima) to be named Lubricantes Andinos S.A. (hereafter "Lubriansa") and which will be domiciled in the city of Guayaquil, Republic of Ecuador, with a subscribed capital in Ecuadorean sucres equivalent to US \$1,800,000.
2. To subscribe for shares in Lubriansa, for and on behalf of VII, the equivalent in Ecuadorean sucres up to US \$918,000 and to pay the equivalent in Ecuadorean sucres of US \$321,300 which is thirty-five percent (35%) of the amount due Lubriansa for the shares subscribed.
3. To present all applications and take all steps necessary in order to obtain the registration of this investment, and VII's investment in shares of Lubrival S.A. (hereafter "Lubrival"), as required by Ecuadorian law.
4. To represent and vote VII's shares, pursuant to VII's instruction, at: (i) the general shareholders' meeting of Lubriansa that will be organized as authorized in this power of attorney, and (ii) the general shareholders' meeting of Lubrival.

A large, handwritten signature is written over the fourth item of the list of powers, starting from the word "To represent" and ending with "Lubrival". The signature is written in black ink and is quite large relative to the surrounding text.



This power of attorney shall remain in effect until the above mentioned mandates have been accomplished or until it is revoked in writing by the undersigned, whichever shall occur first.

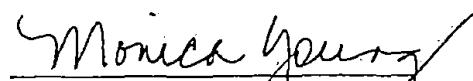

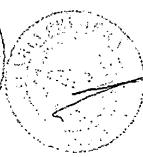

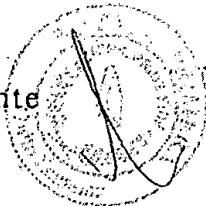




Sépase por el presente instrumento que el suscrito, Lillian Williams, en su calidad de Vicepresidente de Valodine International, Inc., una sociedad debidamente organizada existente bajo las leyes de Delaware y con oficinas principales en 3499 Dabney Dr., Lexington, KY 40509 (en adelante "VII"), por el presente instrumento nombra y designa a PBP Representaciones Cía. Ltda., Quito, Ecuador, como la apoderada de VII en el Ecuador, con plenos poderes de substitución y revocación, autorizándoles, a nombre y en representación de VII, para hacer lo siguiente:

1. Llevar a cabo todos los actos y firmar todos los documentos que sean necesarios para organizar una sociedad anónima que se denominará Lubricantes Andinos S.A. (en adelante "Lubriansa") y que estará domiciliada en la ciudad de Guayaquil, República del Ecuador, con un capital suscrito en sucesos ecuatorianos equivalente a US\$ 1.800.000.
2. Suscribir las acciones de Lubriansa por y a nombre de VII, hasta un monto en sucesos ecuatorianos equivalente a US\$ 918.000 y pagar un monto en sucesos ecuatorianos equivalente a US\$ 321.300, lo que representa el treinta y cinco por ciento (35%) de la suma que Lubriansa deberá pagar por las acciones suscritas.
3. Presentar todas las solicitudes y tomar todas las acciones necesarias para obtener el registro de esta inversión y de la

inversión de VII en acciones de Lubrival S.A. (en adelante "Lubrival"), según lo requieran las leyes ecuatorianas.



4. Representar y dar el voto correspondiente a las acciones de VII, según las instrucciones de VII, en: (i) la junta general de accionistas de Lubriansa que será organizada según se autoriza en este poder y (ii) la junta general de accionistas de Lubrival.

Este poder deberá permanecer en vigencia hasta que los mandatos antes mencionados hayan sido cumplidos o hasta que sea revocado por escrito por el suscrito, lo que ocurra primero.
