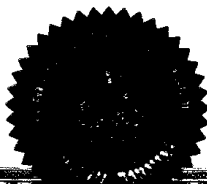

7. In so far as is evidenced by the documents filed with this Office, the Company is in good legal standing.


