- 1.- This Special Power of Attorney will grant the proxy all faculties stated in article 6 of the Ecuadorian Companies Law, amendment by the Reformatory Law to the Companies Law published in the Official Gazette No. 591 dated May 15, 2009.
- 2.- The proxy may represent **DANEC GROUP LLC** to answer any plaint or claim as shareholder of the Ecuadorian Company **ECUAPALMA S.A.**, and comply with the corresponding obligations.
- 3.- Issues annually the certification required by Article 115 letter h) of the Companies Law related to the Company's shareholder list, including all the information requested by the law and the corresponding resolution issued by the Superintendency of Companies.

This Special Power of Attorney shall not be deemed or construed to cause The Company: (i) to have a permanent establishment in Ecuador; (ii) to enroll in the National Register of Taxpayers in Ecuador; or (iii) to submit Statements of income taxes.

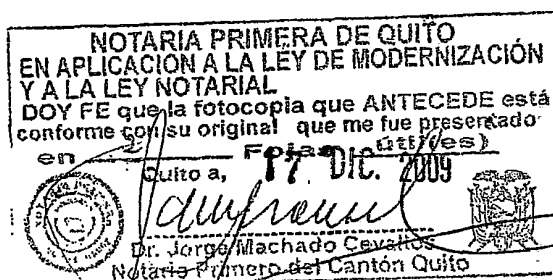
