
LIMITED POWER OF ATTORNEY FROM MAMA JOFRI, LTD. TO MR.

The undersigned hereby ratifies all that its said attorneys-in-fact may lawfully do, or cause to be done, by virtue hereof.


This Limited Power of Attorney shall be effective as of the date set forth below and shall continue until revoked by the Corporation.


