


POWER OF ATTORNEY

- b) To fulfill and accomplish, in the Republic of Ecuador, any contract or obligation legally binding to **THE ONE COMPANY LTD.**



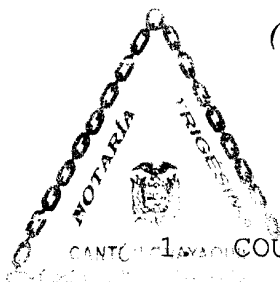
