This authority may be exercised before any court, tribunal or administrative authority.

3. The administrative authority is advised and is directed to designate the person or persons initially or eventually appointed to the job as follows: When one of the applicants is a woman, the administrative authority will be understood not to exercise the authority granted to it to exercise the same authority if any other suitable method proves to be the designated, except that it may expressly state that it does not intend to do so.

The Secretary is directed to ensure that the public of the country is kept fully informed of all matters and not to leave the allegations named that it may have granted.

The provision of all rules may be set aside by the administrative authority.
