SPECIAL POWER OF ATTORNEY

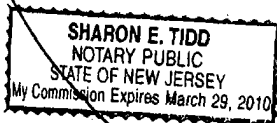

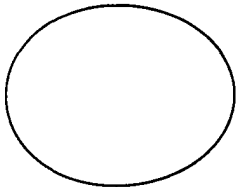
