

KNOW ALL MEN BY THESE PRESENTS, that Green Bay Prover Generation POIC Holding Limited, a corporation duly organized and existing under the Jaws of Canada and domiciled in Suite 1700, Brunswick Square, I Germain Street, Saint John, New Brunswick, E2L 4V1 (the "Company") with this instrument hereby grants a General Power of Attorney in favor of Gaston Danilo Cevallos Andrade (the "Attorney"), resident of Quito, Ecuador, as a true lawful General Attorney-in-Fact of the Company in the Republic of Ecuador and conferring all powers necessary to effect the following on behalf and in the best interests of the Company:

- 1. To act as the General Attorney-in-Fact of the company in the courts of law in the Republic of Ecuador and other state or private entities therein, with such ample and sufficient powers as to comply with the laws of the Republic of Ecuador.
- 2. To perform all legal acts and affairs that will take place in the Republic of Ecuador, including without limitation the ability to answer claims and to meet commitments, including those powers contemplated by Article 44 of the Ecuadorian Code of Civil Procedure.
- 3. To represent the Company, including attending and voting at any shareholder meetings or any meetings of the board of directors of which the Company is a shareholder.

Notwithstanding any of the foregoing, the General Power of Attorney does not apply to matters in which the Attorney may have a conflict of interest or that would create a liability or contingent liability of the Company exceeding US\$10,000, in each case without the prior written consent of the board of directors of the Company (the "Board").

This power of Attorney is effective on $\underline{Jaman 30}$, 2014, and expires on $\underline{Jama 30}$, 2015 (the "Expiration Date"). This Power of Attorney shall continue in full force and effect as to each authority, office or agency of the Republic of Ecuador with which this Power of Attorney is filed by the Company, until the earlier of (a) a written revocation thereof has been filed by the Company with such authority, office or agency and (b) the Expiration Date.

The Attorney shall provide immediate written notice the Board of every instance the Attorney files or otherwise submits or presents this Power of Attorney to any authority, office or agency in the Republic of Ecuador.


