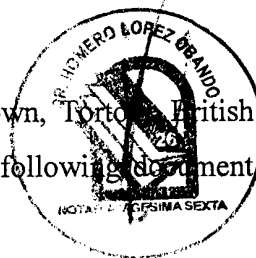

PRIMERA.- COMPARECIENTE.-

JAMES TIMOTHY BRISTOW, en calidad de Representante Legal de **CROP SOLUTIONS LIMITED** (en adelante "MANDANTE").- Debidamente autorizado(s) y facultado(s) en la calidad que comparecen.

SEGUNDA.- PODER ESPECIAL.-

- a) Representar al MANDANTE, en los actos que sean necesarios ante entidades públicas, privadas, administrativas o judiciales, única y exclusivamente por su calidad de MANDATARIA, especialmente pero no limitado a: i) la suscripción de títulos de acción; ii) comparecer a las Juntas Generales que se celebren, pudiendo proponer, discutir y votar sobre los puntos a tratarse iii) presentar solicitudes a órganos de control ecuatorianos; iv) registrar la inversión en el Banco Central del Ecuador; v) realizar convocatorias.
- b) Contestar y presentar demandas, representar judicial y extrajudicialmente para defender los derechos e intereses de la MANDANTE.
- c) La MANDATARIA está facultada al tenor del Art. 6 de la Ley de Compañías, especialmente, a contestar demandas y cumplir las obligaciones respectivas que eventualmente le correspondan o sean por cuenta de LA MANDANTE.
- d) La MANDATARIA, podrá hacer, a nombre del MANDANTE, todo aquello que sea necesario para cumplir a cabalidad

FIRST.- APPEARER.-

JAMES TIMOTHY BRISTOW, in his capacity as Representative of **CROP SOLUTIONS LIMITED** (hereinafter "PRINCIPAL").- Able to execute contracts and assume obligations, acting in their capacity and for the rights they represents.

SECOND.- SPECIFIC POWER.-

PRINCIPAL, freely and voluntarily hereby grants this SPOA to MARIANA VILLAGOMEZ ALVAREZ and appoints her as "Attorney-in-fact", hereinafter also referred to as "AGENT", so that she shall have the full power and authority, in the name and on behalf of the PRINCIPAL, to undertake and perform only the following acts:

- a) To act on behalf of the PRINCIPAL, in necessary acts before public, private, administrative or legal entities, only and exclusively in her capacity of AGENT, specially but not limited to: i) subscription of Shares in consultation with any one director of the PRINCIPAL; ii) attend to the General Shareholders Meetings that might be held, being capable to propose, discuss and vote on the matters to be known; iii) file applications before Ecuadorian control entities; and, iv) register the investment at the Central Bank of Ecuador.
- b) Reply and file claims, whether judicial and extra-judicial, in consultation with any one director of the PRINCIPAL, in order to safeguard the rights and interests of the PRINCIPAL.
- c) The AGENTS are entitled to, under Article 6 of the Companies Law, in particular, reply demands and enforce the obligations may be subject to be charged to THE PRINCIPAL.
- d) On behalf of the PRINCIPAL, the AGENT shall undertake all necessary procedures in order to fully accomplish the assignment conferred within this instrument and
