

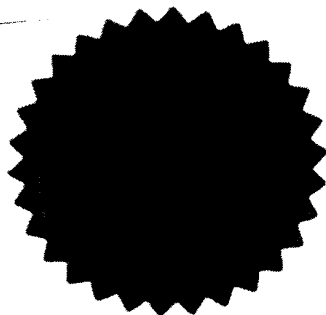

The undersigned, being the Director of the Company, does hereby adopt the following resolution:

1. To grant a limited power of attorney to Mr Jose Alberto Sandoval Munoz ("the Attorney"), a Ecuador national resident in Ecuador, and holder of Ecuador ID Card Number 090230881-6, for the purposes of signing any and all documentation and performing any and all acts necessary to effect the following transactions:
 - a. To purchase shares in RUMBESA, INMOBILIARIA RUMBO S.A. (collectively "the Shares"), on behalf of the Company.
 - b. To exercise the voting rights attached to the Shares ("the Voting Rights") either at meetings of the shareholders or by way of a resolution of the shareholders. PROVIDED THAT in order for the Attorney to validly exercise the Voting Rights in his capacity as the Company's proxy, the Company must have been given at least 3 working days' notice of the Attorney's intention to exercise the Voting Rights, and have consented in writing to the Attorney's proposed use of the Voting Rights.
 - c. Executing on behalf of the Company the form required by the Superintendencia de Compañías del Ecuador in order to disclose the identity of the shareholders of the Company.


